



Full Membership Dues

The cost of full annual membership with Ohio Children’s Alliance is based on your agency’s previous fiscal year expenditures. Most non-profit agencies can find this figure on line 18 of their IRS 990 form. Agencies may also find this figure on their JFS 02911 Single Cost Report form under “Total Agency Cost” section.

Applying Online or Requesting an Invoice

Your organization may simply apply online @ <https://www.ohiochildrensalliance.com/membership>, to have an invoice automatically generated. Click the Join Us button, and in the online form, be sure to enter your agency's 990 expense information in the appropriate field in order to populate the invoice with the accurate level of annual member dues. If mid-year, we will prorate your member invoice for the remaining month's of the year. Payment of Dues
